## FAQs: COVID-19 and Real Estate Contracts

#### How does COVID-19 affect my pending real estate contract?

Given the ongoing global pandemic and related public and private closures, scheduled contract closings may experience delays. When determining what such delays mean for your pending real estate contract, it is essential that you refer to the terms of the contract.

The most predominant contract form used locally, FAR BAR "As Is", contains Force Majeure provisions that may excuse a party's non-performance of obligations. The definition of Force Majeure in the FAR BAR "As Is" Contract does not expressly include pandemics or epidemics. It does, however, address limitations on a party's ability to perform its obligations under the contract. If either party is unable to perform their obligations due to a qualified Force Majeure, the non-performing party will not be held in default, or liable for damages. Furthermore, all contract deadlines, including the closing date, will be extended up to seven days after the Force Majeure no longer prevents the performance under the contract and for up to 30 days beyond the contract closing date. For a delay more than 30 days, either party may terminate the contract with written notice, the deposit shall be returned to the buyer, and both parties would be released from all further obligations.

Given the uncertainty of whether Force Majeure provisions will apply, the Florida Association of Realtors recently circulated a COVID-19 Extension Addendum to Contract to clarify any mutually agreed to extensions.

#### Rep's Lentil Soup with Lemon

During these trying times, it's all about preparation. This is a flavorful, easy soup that can be batched for lunch or dinner making it a no-hassle meal. This soup is vegan, gluten-free and low-fat. Don't skimp on the lemon zing, which makes this recipe sing! (Serves 8; 12 cups)

- 1 lb brown or large green lentils, rinsed and picked over
- 10 cups vegetable broth
- 2 tsp ground coriander
- 1 ½ tsp cumin
- 2 ½ tsp dried oregano
- 2 bay leaves
- 1 lb fingerling potatoes, scrubbed and cut into ½-inch dice
- 1 small butternut squash (1 lb), peeled, seeded and cut into 1/2-inch dice (about 3 cups)
- 2 tbsp olive oil
- ▶ 1 large onion, chopped
- 3 large garlic cloves, finely chopped
- 2 tsp kosher salt, or more to taste
- 1/2 tsp freshly ground black pepper, or more to taste
- 1/3 cup fresh lemon juice
- 2 lemons
- Hot sauce to taste

In a large soup pot over medium-high heat, combine lentils, and seasoning. Bring to a boil, then reduce heat to low. Simmer about 30 minutes. Add potatoes and squash, recover and cook another 15–20 minutes, until tender. Meanwhile, in a large skillet over medium heat, heat olive oil. Add onion, and cook, 3–4 minutes while stirring. Add garlic and cook, stirring, until soft, 3 minutes. Add mixture to the soup. Add salt and pepper to taste. Pick out and discard bay leaves. Just before serving, stir fresh freshly squeezed lemon juice into the soup. Serve the soup hot.
