# FAQs: Selling Your Home

#### Should I engage the services of a licensed real estate professional or broker?

You know what you originally paid, you know your improvement costs, but only a real estate professional will know the market value of your home. You certainly don't want to underprice your home! Conversely, an unrealistically high asking price may leave your home unsold for months. A real estate professional will know both your home's value and current market trends.

#### *Do I need to provide my purchaser with a termite or home inspection report or survey?*

No, under a standard "as is" contract you are not required to pay for these items for your buyer. If these items are desired, your buyer is responsible for procuring and paying for them. However, if you have copies of a termite or home inspection report or survey, your contract may require you to produce

any such items already in your possession. The production of said items may also be beneficial for certain disclosure requirements under your contract.

# Do I have to sell my home in "perfect condition"?

No. Before listing your home, you may wish to make any repairs and/or improvements your real estate professional suggests. Then, I recommend you only sign an "as is" purchase and sale agreement.

While you are not required to make any improvements under an "as is" purchase and sale agreement, you still have certain disclosure requirements for any latent defects known by you and not otherwise readily observable by the buyer.

# n Our Favorite Recipes



### Rep's Apple Fennel Coleslaw

The firm and title company hosted a "Burger Bash" to celebrate the second anniversary of our new building. Attorney Rep DeLoach added to the menu with his tasty apple fennel coleslaw. It's not only a delicious summer recipe but also suitable for those who are dairy-free or vegan. (serves 10–12)

- 1 small green cabbage (about 1 pound), shredded (about 5 cups)
- 1 small fennel bulb, thinly shaved (about 1 cup), reserve fronds for garnish
- 1 small red onion, thinly sliced (about <sup>3</sup>/<sub>4</sub> cup)
- 1 tart-crisp apple (e.g. Granny Smith or Honeycrisp) peeled, cored, and julienned
- 1 tsp kosher salt, or more to taste
- ► 1/4 cup apple cider vinegar
- 1/4 cup neutral oil (e.g. grapeseed or canola)
- Juice of 1 lime (about 2 tbsp)
- 2 tsp honey, or more to taste
- 1 tsp celery seed
- ▶ 1/2 tsp freshly cracked black pepper
- ½ cup loosely packed chopped fresh cilantro, mint, basil, or a fresh tender herb of your choosing

In a big bowl, mix together cabbage, fennel, onion, and apple. Add salt to taste and mix well. In a small bowl or jar, mix vinegar, oil, lime juice, honey, celery seed, and pepper. Taste the mixture and add more honey if you want it sweeter. Gradually pour the vinaigrette over the slaw ingredients. Use just enough dressing to lightly coat all the cabbage. You may have some dressing left over. Mix the slaw to spread the dressing evenly. Then, add cilantro and mix again. If desired, sprinkle with fennel fronds. You can serve immediately, but it tastes better if you let it rest for about 15 minutes. The cabbage and onions will absorb the dressing's flavor the longer it sits.
