

Chantal's 7-Layer Dip

This healthy 7-layer dip recipe is fresh, flavorful, and absolutely delicious! Always a crowd-pleaser for potlucks, game days, and holidays. (serves 10)

1 (15 oz) can refried beans (vegetarian optional)

Taco Layer

- 1¾ cup plain Greek yogurt (whole milk)
- ► 1 taco seasoning packet

Guacamole Layer

- ► 2–3 ripe avocados
- ► 2–3 tbsp chopped cilantro
- 1 jalapeño, seeded & diced
- ► ½ lime, juiced
- Salt and pepper to taste

Remaining Layers

- ¾ cup shredded cheddar or Mexican cheese
- ► 1½ cup grape tomatoes, quartered
- ► ¼ cup sliced black olives
- 2 tbsp finely diced onion (red or green)
- ► ½ cup chopped cilantro
- Jalapeño slices (optional)

Spread beans evenly at the bottom of a 9x9 pan. Mix yogurt and taco seasoning; layer over beans. Mash avocados, stir in cilantro, jalapeño, lime juice, salt, and pepper; spread on top. Add remaining layers in order: cheese, tomatoes, olives, onion, cilantro, jalapeño slices. Cover and refrigerate until ready to serve (best made same day). Serve with chips (tortilla, plantain, or pita) or fresh vegetables (carrot sticks, celery, or cucumber slices).
